



## Owner Agreement

I, \_\_\_\_\_, hereby certify that my dog(s): \_\_\_\_\_ is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I understand that attending a doggie daycare program is not without risk of injury or illness. I understand that even with extreme care and supervision, illness and injury can occur. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog(s) or to my dog(s) while my dog(s) is/are attending The Barking Lot of Hamden.
2. I further understand and agree that in admitting my dog(s) to daycare, The Barking Lot of Hamden, has relied upon my representation that my dog(s) is/are in good health, does not have and has not had within the last 30 days any communicable diseases, and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. I further understand that daycare poses certain risks, including, but not limited to, contagious illness, parasites, and possible injury or death to my dog(s) and to myself. Owner hereby voluntarily assumes the risks associated with my dog(s) and/or myself participating in daycare, as well as the risks related to our presence on The Barking Lot property, including but not limited to, dog bites to humans and/or other dogs and the transmission of illness, disease and/or parasites.
4. I further understand that The Barking Lot has my dog(s) best interest and his/her safety is a top priority. I hereby authorize The Barking Lot, its employees and volunteers to take whatever steps they deem necessary for the safety, health and well being of my dog(s) while under the care of The Barking Lot, including but not limited to emergency veterinary services should my dog require it as determined by The Barking Lot in its sole discretion. Owner hereby accepts full responsibility for the payment of such services and related expenses, and releases The Barking Lot from any liability for payment for such services and expenses.
5. I further understand that The Barking Lot may capture video or photography of my dog and hereby authorizes The Barking Lot to use, broadcast and/or reproduce such video and/or print. Owner has no right to compensation for any use of such images by The Barking Lot.
6. I understand The Barking Lot can refuse any dog at any time at their own discretion.

I certify that I have read and understand the conditions, and statements of this agreement, including the following:

- Daycare Packages are PAID IN FULL, are non-refundable and valid for 6 months from the date of purchase.
- The Barking Lot provides elevated dog beds in all of our suites. If your dog destructive and chews beds, it is your responsibility to request the removal of our beds at check-in. We will replace the bed with soft blankets or you can bring a bed or favorite blanket from home. If the beds are damaged, you are subject to \$35.00 fee.

**Drop-off & Pick-up-** Monday- Friday, Drop off is between 3:00- 7:00 p.m. on day of arrival. Pick-up is between 7:00-11:00a.m. on day of departure. Early check-in and late check-outs are subject to a half-day of daycare. There are no drop-offs or pick-ups between 11:00 a.m.- 3:00 p.m.

**Saturday and Sunday, check-in and check-out are between 5:30-6:30p.m. only.**

**Cancellations-** If you have a reservation and do not cancel with **4 days notice** or do not show up, you will lose your full 50% deposit that is **due at time of reservation**, so please remember to call us ahead of time. All major Holidays require 7-day notice for cancellation.
